Subject: Item 1 – Authorize \$35,000 For The Lower Administration Building

Remediation

# Recommendation:

The Ad Hoc Building Committee ("Committee") recommends the Board of Directors approve and authorize the General Manager, at the direction of the Committee, to enter into an agreement for mold testing and remediation at the lower administration building ("Building") in an amount not to exceed \$35,000.

### Background:

The Building was tested for and has been found to contain mold. Recently, the Building was tested for asbestos and tested negative. In an effort to establish the condition of the Building, remediation must begin. When the Building condition is known, the Committee will report the findings to the Board. The Committee received several bids for mold remediation and is currently updating the bids based on the fact that the building has no asbestos.

# Fiscal Impact:

In fiscal year 2022 – 2023, Water and Sewer Operations Capital Improvement Projects Budget provided \$150,000 of funding for building modifications with Water funding 75% and 25% from Sewer. Total costs for the remediation are expected not to exceed \$35,000.

# **Conclusion:**

The Committee wants to continue forward progress towards a permanent solution pertaining to the building and onsite housing of the General Manager and Chief Financial Officer.
