AN ORDINANCE OF THE BOARD OF DIRECTORS OF THE IDYLLWILD WATER DISTRICT AMENDING ORDINANCE NO. 50 (EMERGENCY WATER CONSERVATION PLAN)

RECITALS

WHEREAS, THE BOARD OF DIRECTORS OF THE IDYLLWILD WATER DISTRICT HAS FOUND AND DETERMINED THAT, DUE TO A PRESENTLY THREATENING CONDITION OF DROUGHT, IT IS IMPERATIVE THAT THE DISTRICT TAKE ALL REASONABLE STEPS AT THIS TIME TO CONSERVE THE USE OF WATER SUPPLIED BY THE DISTRICT; AND

WHEREAS, BASED UPON THE BEST AVAILABLE INFORMATION, THE BOARD OF DIRECTORS HAS FURTHER FOUND AND DETERMINED THAT THE PRESENTLY THREATENING CONDITION OF DROUGHT IS EXPECTED TO WORSEN IN 1990 AND THAT THE POTENTIAL FOR A SEVERE WATER SHORTAGE WITHIN THE DISTRICT IS EXTREMELY HIGH; AND

WHEREAS, THE BOARD OF DIRECTORS ENACTED ORDINANCE NO. 50, AN ORDINANCE ESTABLISHING AN EMERGENCY WATER CONSERVATION PLAN AND PROVIDING PENALTIES FOR VIOLATION THEREOF, DATED JUNE 14, 1988; AND

WHEREAS, THE BOARD OF DIRECTORS HAS FOUND AND DETERMINED THAT IT IS NECESSARY TO AMEND ORDINANCE NO. 50 TO INCLUDE A PROVISION IN SECTION 4, PARAGRAPH B, SUBSECTION b:

9:00 A.M. and 5:00 P.M.

SECTION 4, PARAGRAPH B, SUBSECTION e:

with running hose

SECTION 4, PARAGRAPH 2 (STAGE 2 WATER SHORTAGE WARNING):

OR WHEN THE GENERAL MANAGER DETERMINES THAT WITHIN THE NEXT 30 DAYS WATER SUPPLIES WILL NOT BE SUFFICIENT TO ALLOW THE RECOVERY OF RESERVOIR STORAGE TO HISTORICALLY NORMAL LEVELS BETWEEN WEEKENDS AND HOLIDAY PEAK DEMAND PERIODS.

SECTION 4, PARAGRAPH C, ADD SUBPARAGRAPH d:

PROHIBITING WASHING MOTOR VEHICLES AND OTHER FORMS OF TRANSPORTATION AND MOBILE EQUIPMENT.

WHEREAS, THE BOARD OF DIRECTORS HAS FOUND AND DETERMINED THAT THE ENACTMENT OF THIS ORDINANCE IS ESSENTIAL TO (1) PROTECT THE HEALTH, SAFETY AND WELFARE OF THE INHABITANTS OF THE DISTRICT, (2) ASSURE THE MAXIMUM BENEFICIAL USE OF THE WATER SUPPLIES OF THE DISTRICT, AND (3) ENSURE THAT THERE WILL BE SUFFICIENT WATER SUPPLIES TO MEET THE BASIC NEEDS OF HUMAN CONSUMPTION, SANITATION AND FIRE PROTECTION.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE IDYLLWILD WATER DISTRICT:

SECTION 1. APPLICATION. THE PROVISIONS OF THIS ORDINANCE SHALL APPLY TO ALL PERSONS AND PROPERTY SERVED WITH WATER BY THE DISTRICT.

SECTION 2. AMENDMENT TO ORDINANCE NO. 50.
ORDINANCE NO. 50 OF THE IDYLLWILD WATER DISTRICT IS
HEREBY AMENDED BY ADDING THE FOLLOWING SUBSECTION b AND
e, SUBPARAGRAPH d, AND PARAGRAPH 2 (STAGE 2 WATER
SHORTAGE WARNING) TO SECTION 4, AS FOLLOWS:

SECTION 4, PARAGRAPH B, SUBSECTION b:

9:00 A.M. AND 5:00 P.M.

SECTION 4, PARAGRAPH B, SUBSECTION e:

WITH RUNNING HOSE

SECTION 4, PARAGRAPH 2 (STAGE 2 WATER SHORTAGE
WARNING)

OR WHEN THE GENERAL MANAGER DETERMINES THAT
WITHIN THE NEXT 30 DAYS WATER SUPPLIES WILL
NOT BE SUFFICIENT TO ALLOW THE RECOVERY OF
RESERVOIR STORAGE TO HISTORICALLY NORMAL
LEVELS BETWEEN WEEKENDS AND HOLIDAY PEAK
DEMAND PERIODS.

SECTION 4, PARAGRAPH C, ADD SUBPARAGRAPH d:

PROHIBITING WASHING MOTOR VEHICLES AND OTHER
FORMS OF TRANSPORTATION AND MOBILE EQUIPMENT.


SECTION 3. EFFECTIVE DATE. THIS ORDINANCE
AMENDMENT SHALL BECOME EFFECTIVE ON THE DATE OF ITS
ENACTMENT. THE GENERAL MANAGER OF THE DISTRICT IS
HEREBY DIRECTED TO PUBLISH THIS ORDINANCE AMENDMENT IN
ITS ENTIRETY ONCE IN THE IDYLLWILD TOWN CRIER, AND TO
POST A TRUE, CORRECT AND COMPLETE COPY OF THIS
ORDINANCE AMENDMENT IN THREE PUBLIC PLACES WITHIN THE
DISTRICT.

1990.
